

#AlwaysUpForAChallenge

Terms & Conditions

1. Terms and conditions applicable to the #AlwaysUpForAChallenge” (“Competition”) conducted by Mahindra & Mahindra South Africa (Pty) Ltd (Mahindra South Africa) (“Promoter”).
2. The Competition will run from Monday 1st October 2018 to Sunday 31st March 2019. Entries received after the closing date will not be considered.

WHO CAN ENTER

1. Participants must be 18 years or older, have a valid driver’s license, have a valid identity document, be a South African citizen or a permanent resident of the Republic of South Africa and reside in the Republic of South Africa during the period of the Competition up until the redemption of the prize (“Participants”/ “you” / “your”).
2. Participants wishing to enter and be eligible for a prize must vote for a challenge on <https://alwayssupforachallenge.co.za>.
3. Only 1 (one) entry per person will be considered by the judges, winners will be determined according to the judges’ discretion.
4. Entries must be entered by the participant and not by a third party doing so on the participant’s behalf.

HOW TO ENTER

1. Participants are to register their details and vote.
2. The winners will be determined during and after the registration period and will be selected by a panel of judges.
3. The winners will be announced as and when selected from 30th November 2018 to 31st March 2019. The winner will be contacted via telephone or email on the phone number and/or e-mail address registered on <https://alwayssupforachallenge.co.za>.
4. Mahindra South Africa will make 3 (three) attempts to contact and notify the selected winner. If the selected winner cannot be contacted personally after 3 (three) attempts, or if after first being contacted by the Promoter, is not reachable, or the winner fails to provide the Promoter with the required information to hand over the prize, the winner will forfeit the prize and a replacement winner will be selected from the names drawn from remaining qualifying participants. This process shall continue until the winner has been contacted and the prize has been awarded in terms of the Competition rules.
5. Mahindra South Africa will facilitate all prize distribution arrangements.

PRIZE

1. Participants can enter and stand a chance to win a 1 (one) of 5 (five) Mahindra drive experiences where the winner will choose between a Mahindra KUX500 and KUV100 for a 1 (one) week long test drive with one tank of fuel included.

2. By entering, a Participant acknowledges that personal information about the Participant will be shared with the Promoter and Mahindra Dealerships to the extent necessary to conduct the competition and for the prize to be delivered to prize winner.
3. All personal information relating to the Participants will be used solely in accordance with South African consumer and data protection legislation.
4. By entering this competition and winning, the winner may be required to participate in marketing or promotional activities that include social media postings.

GENERAL

1. The Promoter of this competition is Mahindra South Africa, registration number 1996/016456/07.
2. Participants may not enter or receive a prize if they are directors, members, partners, employees, agents of or consultants of the Promoter and their subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by Mahindra South Africa, or their spouses, life partners, immediate family members or business partners.
3. By entering this Competition, all Participants agree to be bound by these terms and conditions, and the Promoters decision regarding any issue with the Competition will be final and binding and no correspondence will be entered into.
4. Incomplete or incorrect entries will not be eligible to be entered into the draw.

14. The laws of the Republic of South Africa shall govern these competition terms and conditions and the courts of South Africa shall have exclusive jurisdiction.
